NJC Pay 2011-2012

This circular updates branches on Eric Pickles' response on NJC pay.

We have now received a response from Eric Pickles, who like Baroness Eaton, has said that, because he has no formal role in NJC negotiations, 'there would seem little to be gained from us meeting as you suggest'. A copy of the full letter is attached.

The NJC Executive Trade Union Side will be meeting on 12 April 2011 to consider the next steps.

In the meantime, please don't forget to let us know what your council has budgeted for pay in the year 2011-2012. It is becoming clear that some councils have budgeted to meet our claim – or similar increase. A small number have also paid it.

It is important to keep highlighting how rising inflation and fuel prices are impacting on our members, especially with the prospect of the 3% increase in pension contributions announced by the Government. With local elections in many councils in May, we can put pressure on councillors and MP's to do the right thing by our members. **Please make sure that your branch has written to all your councillors and MP's.**

Dear Joint Secretaries

Thank you for your letter of 11 March in which you ask for a meeting to discuss the pay arrangements for 2011/12 for local government services.

While the Government's overall policy on public sector pay sets the context in which decisions about local government pay are made, those decisions remain a matter for negotiation between local government employers and trade unions. Government is not party to those negotiations.

I understand that, for 2011/12, the Local Government Employers have concluded, after consultation with councils, that a pay award would not be affordable and that the protection of services and jobs should take greater priority.

Given that I have no role in negotiations about pay arrangements in local government, there would seem to be little to be gained from us meeting as you suggest. I know, however, that you will continue to work constructively with my officials on other issues where there is a Departmental interest, including reform of the Local Government Pension Scheme.
